Application Requirements

1. Priority will be given to licensed clinicians or those under clinical supervision in preparation for licensure with a Master's degree in social work, counseling or related discipline.
2. Second level consideration will be given to Master's level professionals (social work, counseling or related discipline) that do not hold a clinical license and are not under clinical supervision.
3. Third level consideration will be given to Bachelor's level social workers with at least 5 years of adoption experience.
4. Must be currently employed in a clinical practice setting.
5. Must demonstrate in your personal statement and resume the following information:
 - ◆ A strong clinical background.
 - ◆ An interest in working with adopted persons, prospective adoptive parents, birth parents and birth families, adoptive families and kinship families in a clinical setting.
 - ◆ A description on how you would incorporate the learning from the TAC program into your clinical practice.

Participants must commit to all training dates and make-up sessions and complete all assignments.
