

## Fees

Course Fee: \$500 if paid in full by 10/15; or 2 installments of \$275 each (time of acceptance and by session 8).

Participants who successfully complete the classroom component and the case consultation are eligible to sit for an assessment. Those passing will receive national accreditation as an adoption competent mental health professional TAC graduate.

## Application Requirements

Master's degree or higher in social work, counseling or related discipline. Current professional license or under clinical supervision to prepare for licensure.

Working in a clinical capacity at an agency specializing in adoption, private practice or community mental health setting serving adoptive families.

- or -

Master's level professional in social work or related discipline who does not hold a clinical license but whose work involves interface with members of the adoption kinship network.

**In order to receive the Certificate of Completion and CEU credits, participants are required to attend all training modules and all clinical consultations, including presenting 1-2 cases, completing post-module surveys and must pass the final assessment.**

## About TAC

Created by the Center for Adoption Support and Education (C.A.S.E.) with the assistance of a National Advisory Board of adoption experts, TAC is a comprehensive, evidenced-based post-Master's curriculum designed exclusively for licensed mental health professionals, providing clinical knowledge and skills needed to effectively serve the adoption and kinship network.

TAC is designed to increase families' and individuals' access to adoption competent mental health professionals and to improve the well-being of adopted children and youth and their families.

Through classroom and remote instruction as well as clinical case consultation, TAC consists of 18 areas of knowledge, values and skills that are critical to adoption-competent mental health services. TAC is a rigorously evaluated program and is rated by the California Evidence Based Clearinghouse for Child Welfare. TAC offers 72 hours of instruction over 12 modules. Graduates earn CEU's, certificates of completion and national recognition in C.A.S.E.'s Directory of Adoption Competent Professionals.

- ◆ Impact of genetics and past experiences on adjustment and psychological well-being of adopted children.
- ◆ Trauma's impact on adopted children and tools to support recovery from adverse beginnings.
- ◆ Identity formation for adopted youth & young adults.
- ◆ Supporting adoptive parents in developing therapeutic parenting strategies.
- ◆ Assessment and intervention skills with adoptive families and birth families.
- ◆ Developmental stages of adoptive families and the process of adoptive family formation and integration.
- ◆ Adoption openness and ongoing connections.
- ◆ Needs of transracial and transcultural families.
- ◆ Evidence-based and evidence informed practices and interventions with individuals affected by adoption.
- ◆ Working effectively with service systems and the community on behalf of adoptive families.
- ◆ Strengthen the learning process through the case consultations, resulting in strong transfer of learning to practice.
